

RESOLUTION NO. 25-228

**A RESOLUTION MAKING AN APPOINTMENT TO THE OFFICE OF  
THE CANYON COUNTY CLERK**

The following resolution and order was considered and adopted by the Canyon County, Idaho Board of Commissioners (“Board”) on this 11<sup>th</sup> day of December, 2025.

Upon the motion of Commissioner Van Beek and the second by Commissioner Brooks, the Board resolves as follows:

**WHEREAS**, Idaho Code § 31-801 grants general powers and duties, subject to the restrictions of law, to the boards of county commissioners in their respective counties; and

**WHEREAS**, Idaho Code § 31-828 grants the Board authority “to do and perform all other acts . . . which may be necessary to the full discharge of the duties of the chief executive authority of the county government”; and

**WHEREAS**, Idaho Code § 31-817 empowers the Board to fill by appointment vacancies that may occur in county offices; and

**WHEREAS**, on November 17, 2025 the written resignation of Canyon County Clerk, Rick Hogaboam, effective January 5, 2026, was received by this Board, pursuant to Idaho Code § 59-902; and

**WHEREAS**, the Canyon County Republican Central Committee, pursuant to that body’s bylaws as well as the procedures established by Idaho Code § 59-906, convened on December 2, 2025, to accept or review applicants to succeed Rick Hogaboam as the Canyon County Clerk; and




**WHEREAS**, the Canyon County Republican Central Committee has fulfilled its process to present names for consideration to the Board of County Commissioners: Jess Urresti and Daniel Lee; and

**WHEREAS**, based on the recommendations and information provided by the Central Committee and this Board’s independent inquiry, and good cause thereby appearing.

**NOW THEREFORE, THE BOARD HEREBY RESOLVES**, pursuant to Idaho Code Chapter 9, Title 59, that Jess Urresti be appointed to the Office of Canyon County Clerk and assume all powers, duties, and obligations of that Office effective January 5, 2026.

IT IS FURTHER RESOLVED BY THE BOARD, that this resolution shall be effective this 11<sup>th</sup> day of December, 2025.
