

You understand that maintenance and use of Data History Services is at your own risk and that ADP will not be required to provide any database updates or fixes. ADP may still perform general programming updates at its discretion.

The Data History Services do not include access to (i) ADP Enhanced Time, ADP Workforce Manager and ADP Data Cloud Services (including, but not limited to Analytics), (ii) use of carrier connections and recruitment integrations, (iii) candidate access to the career center, and (iv) custom reporting support from ADP.

ADP may delete any data stored in ADP Workforce Now database, including client data, in accordance with its then current data retention policies.


ADP may at any time and without notice change the terms of the Data History Services. Your sole remedy because of any changes to the terms is to terminate Data History Services.

The fee for Data History Services is \$400 per month. You agree to be billed for Data History Services by the same method that you were billed for services under your Existing Agreement. If by direct debit of fees, you agree that any existing authorization to debit fees will continue for the duration of your receipt of Data History Services.

ADP may increase the fees at any time upon thirty (30) days' notice to you (in-product notice shall be deemed sufficient notice hereunder). Failure by you to pay the monthly fee for the Data History Services will result in immediate termination of these services.

You may terminate Data History Services at any time by navigating to the "Cancel Access" page in your ADP Workforce Now database and acknowledging the information provided about cancelling access to Data History Services. If you choose to terminate, access to your ADP Workforce Now database will be discontinued at the end of the then current billing cycle. ADP may terminate Data History Services at any time, including for failure to utilize the Data History Services, upon 30 days prior notice. Notwithstanding the foregoing, Data History Services will automatically terminate no later than 60 months from the date Data History Services commenced.

The Data History Services terms set forth herein supplements and do not supersede the Existing Agreement. In the event of any conflict between the terms and conditions stated here and the terms and conditions of your Existing Agreement, the terms set forth herein shall prevail with respect to the Data History Services only. By choosing the option set forth below, you hereby agree that you are a duly authorized representative of your company and that you agree to all of the terms set forth herein.


