

RESOLUTION NO. 26-052

**A RESOLUTION OF THE CANYON COUNTY BOARD OF COUNTY
COMMISSIONERS DESIGNATING POLLING LOCATIONS FOR THE
MAY 19, 2026 ELECTION**

The following Resolution was considered and adopted by the Canyon County, Idaho Board of Commissioners (hereafter the "Board") on the 7th day of April, 2026.

Upon the motion of Commissioner VanBoek and the second by Commissioner Brooks the Board resolves as follows:

WHEREAS, Idaho Code § 31-801 grants general powers and duties, subject to the restrictions of law, to the boards of county commissioners in their respective counties; and

WHEREAS, Idaho Code § 34-301 grants the Board authority to establish a convenient number of election precincts therein; and

WHEREAS, Idaho Code § 34-301 authorizes the county clerk of each county to provide an accurate report and map of precincts within the county and the County Clerk having complied with his mandate and provided the same to the Board; and

WHEREAS, Idaho Code § 34-302 requires the Board to designate a suitable polling place for each election precinct, by the fifth Friday before any election; and




WHEREAS, the next Canyon County election will take place on May 19, 2026; and

WHEREAS, the Board has reviewed the materials provided by the County Clerk, attached hereto and fully incorporated by reference as Exhibit "A," and determined the designated precincts represent a convenient number of election precincts and voting locations.

NOW THEREFORE, finding good cause and upon the recommendation of the County Clerk, the Board hereby designates the polling locations identified on Exhibit "A" as suitable for each election precinct for the May 19, 2026 election.

IT IS FURTHER ORDERED that this Resolution shall be effective the 7th day of April, 2026.
