

SUMMARY OF ORDINANCE NO. 26-015

AN ORDINANCE OF CANYON COUNTY, IDAHO, AMENDING CHAPTER 5, ARTICLE 1, ALCOHOLIC BEVERAGES OF CANYON COUNTY CODE OF ORDINANCES; AND SEVERABILITY CLAUSES; AND EFFECTIVE DATES.

1. **Name of County:** Canyon County.
2. **Formal identification or citation number of Ordinance:** Ordinance No. 26-015.
3. **Descriptive title:** An Ordinance of Canyon County, Idaho Amending Chapter 5, Article 1, Alcoholic Beverages, of the Canyon County Code of Ordinances.
4. **Summary of principal provisions of Ordinance:**
 - a. Amending Chapter 5, Article 1, Alcoholic Beverages of the Canyon County Code of Ordinances.
 - b. Chapter 5, Article 1, Alcoholic Beverages, Section 3, Authority and Purpose, is amended to update the citations to authority.
 - c. Chapter 5, Article 1, Alcoholic Beverages, Section 7, Definitions, is amended to add, modify, and remove definitions.
 - d. Chapter 5, Article 1, Alcoholic Beverages, Section 31, Liquor Catering Permit, is amended to update the section title, and to update the application process for an alcoholic beverage catering permit.
