

RESOLUTION NO. 26-145

**A RESOLUTION OF THE CANYON COUNTY BOARD OF COUNTY
COMMISSIONERS GRANTING CERTAIN PROPERTY OF NOMINAL VALUE TO
COMPUTERS FOR KIDS, INC.**

The following resolution and order was considered and adopted by the Canyon County, Idaho Board of Commissioners ("Board") on this 21st day of July, 2026.

Upon the motion of Commissioner Brooks and the second by Commissioner Holton, the Board resolves as follows:

WHEREAS, Idaho Code § 31-801 grants general powers and duties, subject to the restrictions of law, to the boards of county commissioners in their respective counties; and

WHEREAS, Idaho Code § 31-828 grants the Board authority "to do and perform all other acts . . . which may be necessary to the full discharge of the duties of the chief executive authority of the county government"; and

WHEREAS, Idaho Code § 31-807 authorizes the Board to manage county property subject to restrictions including, but not limited to, those described in Idaho Code § 31-808; and

WHEREAS, certain personal property listed in Exhibit "A" (attached hereto and incorporated herein) is no longer necessary for the county's use as this computer equipment is inoperable or obsolete; and

WHEREAS, the computer equipment described in Exhibit "A" has been salvaged by the county for components to be incorporated into other systems or utilized for replacement parts and is therefore of nominal value; for that reason, the property described in Exhibit "A" is to be discarded in the county landfill or to be recycled as scrap; and

WHEREAS, Computers for Kids, Inc. is a local 501(C)(3) non-profit organization that distributes refurbished computers to students for the students' home use and can accept the equipment described in Exhibit "A" to use towards that end; and

WHEREAS, as property described in Exhibit "A" is no longer necessary for the County's use and is of nominal value, and it of use by Computers for Kids, Inc. to assist in the education of children in our community.

NOW THEREFORE, THE BOARD HEREBY RESOLVES, to grant Computers for Kids, Inc. the computer equipment described in Exhibit "A" in lieu of otherwise disposing of the equipment.

IT IS FURTHER RESOLVED BY THE BOARD, that this resolution shall be effective July 21st, 2026.
