

RESOLUTION NO. 26-144

A RESOLUTION OF THE CANYON COUNTY BOARD OF COUNTY COMMISSIONERS DESIGNATING SURPLUS PERSONAL PROPERTY WITH NOMINAL VALUE AND AUTHORIZING THE DESTRUCTION OF CANYON COUNTY INFORMATION TECHNOLOGY DEPARTMENT EQUIPMENT

The following Resolution was considered and adopted by the Board of County Commissioners of Canyon County, Idaho on the 21st day of July, 2026.

Upon the motion of Commissioner Brooks and second by Commissioner Holton, the Board resolves as follows:

WHEREAS, Idaho Code § 31-801 grants general powers and duties, subject to the restrictions of law, to the boards of county commissioners in their respective counties; and

WHEREAS, Idaho Code § 31-828 grants the Board authority “to do and perform all other acts . . . which may be necessary to the full discharge of the duties of the chief executive authority of the county government”; and

WHEREAS, Idaho Code § 31-807 authorizes the Board to manage county property subject to restrictions including, but not limited to, those described in Idaho Code § 31-808; and

WHEREAS, the Canyon County Information Technology Department (“IT”) has determined that it is no longer in need of certain computer equipment and that the equipment is not suitable for use as parts and/or as a donation to another agency for use; and

WHEREAS, IT has determined such personal property has no current value, has taken it out of service, and it is now surplus property;

WHEREAS, IT desires to destroy certain personal property as requested and described in Attachment “1”;

WHEREAS, the Canyon County Prosecuting Attorney’s Office has reviewed this resolution and rendered advice to the Board and IT;

NOW THEREFORE, the Board hereby resolves and concludes that the equipment as described in Attachment “1” is surplus property with nominal value and is no longer of use to IT.

IT IS HEREBY RESOLVED, that IT is authorized to destroy and/or dispose of the certain personal property described in Attachment “1”. Such disposition shall be under the direction and supervision of the Canyon County Board of County Commissioners through the Information Technology Department Administrator.

IT IS FURTHER ORDERED that this Resolution shall be effective
July 21, 2026.
